

# Waste of Electrical and Electronic Equipment (WEEE) and Battery Statement

Electrical and electronic equipment (EEE) and batteries contain materials, components and substances that may be hazardous and present a risk to human health and the environment when waste electrical and electronic equipment (WEEE) and batteries are not handled correctly.

Electrical and electronic equipment and batteries are marked with the crossed-out wheellie bin symbol indicating that electrical and electronic equipment and batteries should not be disposed of in the regular household waste stream but need to be collected separately. In case batteries contain more than 0,0005% mercury (Hg), 0,002% cadmium (Cd) or 0,004% lead (Pb) (by weight), the corresponding chemical symbol is displayed on the battery.

Users need to follow local recycling regulations to reduce adverse environmental impact in connection with disposal of WEEE and batteries and to increase opportunities for reuse, recycling, and recovery of WEEE and batteries. To facilitate this, free collection points are available in your area. Users are responsible for removing personal data from electronic devices prior to disposal. If possible please remove old batteries or accumulators from the electronic device before you return it for recycling.

#### **Cummins Industrial Battery Statement**

As a producer of industrial batteries under the Waste Batteries and Accumulators Regulations 2009, we **Cummins Ltd.** and **Cummins Electrified Power Europe Ltd** produce **lead acid and lithium-ion industrial batteries**. We are obliged to take back free of charge, waste industrial batteries supplied to an end user for treatment and recycling. We are required to do this in any calendar year we place new industrial batteries on the market. If any of our customers or in certain cases other end users, require us to take back Industrial batteries, they should contact us at [wastebatteries@cummins.com](mailto:wastebatteries@cummins.com). We will agree the necessary arrangements for the return, proper treatment and recycling of the waste industrial batteries.

### **United States**

**USA:** It is illegal to discard a motor vehicle or other lead-acid battery. Recycle your used batteries. State law requires us to accept used motor vehicle batteries, or other lead-acid batteries, for recycling in exchange for new batteries purchased. **California:** Cummins is required by law to charge a nonrefundable \$2 California battery fee and a refundable deposit for each lead-acid battery purchased. A credit of the same amount as the refundable deposit will be issued if a used lead-acid battery is returned at the time of purchase or up to 45 days later along with this dealer's receipt.

**Maine:** A deposit of \$10 will be charged for each new lead-acid battery that is not exchanged with an old lead-acid battery.
